Thank you for registering for our Legislative Reception and Showcase! This email will serve as a reminder for your registration, an opportunity for you to contact us to make any changes necessary, and some important information your attendees should know before they go.

If you have a display table:

We have a display table reserved for your organization as part of your registration. Display tables will line the perimeter of the room, and will come with linen and two chairs. Tables are six feet in length. We do ask you to avoid having such bulky displays that you might encroach upon the display areas of your neighbors! We will be arranging the tables geographically, with vendor display tables 'between' sections. Each table will have a tent card with the organization's logo and name on it. You can arrive to set up your table anytime after 7 AM. You will have to pass through security, and any totes, bags, or other containers are subject to scanning and inspection. Use common sense in remembering what you should and should not bring - no alcohol, weapons, or other prohibited items should be included.

Reception Location: Lowe House Office Building, 6 Bladen Street, Annapolis MD 21401. Rooms 170 and 180.

Getting there

We recommend the Park Place garage, located at One Park Place Annapolis, MD 21401 because of its price, accommodations, and convenient starting location for the free shuttle route leading downtown. You can track the shuttle at <https://accessannapolis.transloc.com/routes>.

The reception is located at the Lowe House Office building on 6 Bladen Street. Metered Parking on the street nearby is limited during the session, and we recommend either taking public transit or choosing one of the city garages. [The Annapolis Circulator](#) is a free shuttle to downtown Annapolis which makes stops near Park Place, Whitmore, Gott's Garage, and Knighton Garage. An additional option is to park at the Naval Academy Stadium Parking Lot and use the [Trolley Shuttle](#) to get downtown. [You can view a full list of options here.](#) Attendees should enter through the visitor's entrance on Bladen Street. After

you pass through security, room 170 and 180 (the Baltimore and Montgomery County Delegation Rooms) will be down the hall on the first floor to your right. You'll see the TAM check-in table where you can pick up your namebadge.



Security

All attendees will have to pass through building security. Any packages, totes, or containers are subject to scan and inspection. Attendees will be given a visitor badge, which should be placed prominently about your person.

Things to know before you make your way through security:

- Bring a **valid driver's license** to pass through security.
- You will go through metal detectors, and your bags will be scanned. Security screening can take time, especially for large groups, so avoid carrying large bags or extra items.
- Food and drinks are strictly prohibited in the House and Senate Chambers, including the gallery. Therefore, please refrain from bringing any such items with you when visiting the Maryland State House for the Floor Sessions.

Dress Code

The dress code in Annapolis is business professional. We will be meeting with legislators and want to showcase the professionalism of our industry!

Enjoying the reception

We will be providing breakfast throughout the reception (8:30 to Noon), along with assorted beverage and coffee. Our photographer will be circulating during the reception, please feel free to ask him to take photos of you as he passes by.

TAM Bus

The City of Annapolis Dept. of Transportation will have a hybrid bus parked between the House and Senate office buildings and the State House. We'll have it staffed during the morning by a rotating set of

volunteers – feel free to stop in anytime! Legislators and staffers will stop by as they walk to and from their offices and the State House.

Special Events

TAM has invited guest speakers to address our attendees, and we will update you as they confirm their attendance. We have also arranged for a special recognition of TAM and our members on the floor of the house and senate chambers. The general assembly will go into floor session in the morning around 10 AM to 10:30 AM. At this time, a loud chime will sound. We invite all our attendees interested in seeing the state house and some action on the floor to join us as we walk across Lawyer's Mall to the State House, where we will head up to the respective House and Senate galleries. Once there, our sponsor will be recognizing TAM and all of our members present during the reception and thanking us for the work we do. Afterwards, we will return to the reception.
