For more than 23 years, Partners In Care (PIC) has enhanced the lives of older adults by engaging them in a rich exchange of service to each other. PIC is a 501(c)3 nonprofit that empowers older adults to remain independent in their homes and engaged in the community. The organization operates as a time exchange whereby its members volunteer their time to help others; and in exchange they receive assistance when requested. Twenty-three years ago PIC was founded with 13 volunteer drivers who provided rides for 13 members. Today PIC's membership has grown to nearly 2,500 older adults who both help the organization and each other in a variety of ways. Although transportation remains the most requested service, member care, handyman, and other reciprocity services are also made available to PIC members.
